AMENDED ARTICLES OF INCORPORATION

OF

PHILIPPINES NORWAY BUSINESS COUNCIL, INC.

(Name of Corporation)

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock and non-profit association under the laws of the Republic of the Philippines.

THAT WE HEREBY CERTIFY:

FIRST: The name of the said association shall be:

PHILIPPINES NORWAY BUSINESS COUNCIL, INC.

SECOND: A. That the purpose or purposes for which such association is incorporated are:

- To promote trade, commerce, industry and investment between Filipino and Norwegian
 public and private sectors, fostering friendly relations, mutual understanding and closer
 economic cooperation between the two countries to contribute to the advancement of both
 economies.
- 2. To provide a forum for discussion and exchange of views on business conditions and issues, both domestic and international, affecting the Filipino and Norwegian companies.
- 3. To acquire, own, hold, buy, sell, exchange, rent or lease, or mortgage or otherwise encumber any real or personal properties or to lend or otherwise invest its funds, moneys or properties in such undertakings and pursuits as may be desired, necessary or proper to achieve or carry out the purpose of the foundation.
- 4. To keep its monies and funds in bank accounts or in trusts to appropriate and expend the same in a manner consistent with and necessary in the attainment and furtherance of its purposes.
- 5. To govern and manage its affairs businesses, funds and properties consistent with and in the promotion of its purposes as an incorporated non-stock, private, charitable Foundation.
- 6. In general, to do all and every act and thing necessary, proper, incidental or in relation to the attainment of its purposes, either alone or in association with other person or entities.

THIRD: That the place where the principal office of the association is to be established is at 12th Floor, DelRosarioLaw Centre 21st Drive corner 20th Drive Bonifacio Global City, Taguig, Metro Manila. (As arrange on 30 April 2015)

FOURTH: That the term for which the association is to exist is fifty (50) years from and after the date of issuance of the certificate of incorporation.
